Callers Liability Insurance for insurance year April 1, 2006-March 31, 2007

Callerlab, a nationwide callers association, offers liability insurance to its individual members and through its affiliates; CDSS is an affiliate of Callerlab and is able to offer the insurance to its members in the United States. CDSS members have no individual status within Callerlab unless they are Callerlab members, subscribers or apprentices in their own right.

This insurance is for *callers only*, not groups. The policy does NOT cover dancers, musicians or your equipment.

The general liability, bodily injury and property damage portion of the policy provides liability coverage in the amount of \$2,000,000 per occurrence, with an aggregate limit of \$3,000,000 per caller, per event. It protects you, the caller, for any acts, or omissions of acts, that result in bodily injury or property damage while you are calling square dances or related activities. ("Related activities" include regular dances, workshops, classes, one night stands, contra, traditional, round dancing and line dancing.) The accidental medical portion provides supplemental insurance for you while you are conducting square dance-related activities; maximum coverage is \$10,000 and this coverage is effective only after your primary carrier, Medicare or other health insurance company has settled a claim. The accidental death/dismemberment portion of the policy covers you while traveling to and from a square dance; coverage for accidental death is \$5,000; coverage for accidental dismemberment may be as high as \$5,000, depending on the loss, with an aggregate limit of \$250,000.

Here's how the program works:

- 1. Insurance coverage is April 1 through March 31; applications are accepted after April 1, but rates are not prorated the premium remains the same throughout he year. *All coverage ends on March 31*.
- 2. You may request that one or two additional insureds the building or hall where you call be listed on the certificate of insurance.
- 3. Certificates of insurance are sent from the insurance company about four weeks after we have received your application and payment.
- 4. The cost of the insurance this year is \$45. Of this fee, \$30 goes to Callerlab and \$15 is used to cover CDSS's administrative costs.
- 5. Payment for insurance must be made out to and sent to CDSS, not to Callerlab. We do the paperwork here, forward payment to Callerlab and request the certificates from the insurance company.
